### What does the fund invest in?

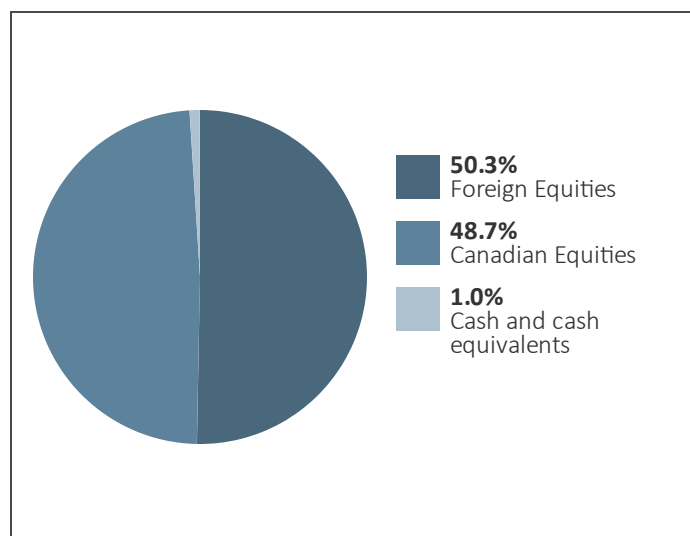
This Fund is a global equity fund that invests in a diversified portfolio consisting primarily of equity securities of companies anywhere in the world.

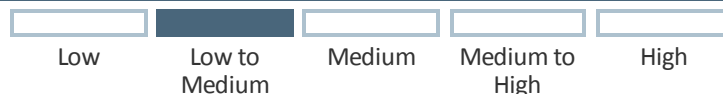


## How risky is it?

The value of the Fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility". In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

Lysander Funds Limited has rated the volatility of this Fund as **low-to-medium**.



This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

## No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

## Average return

---

## Who is the fund for?

---

Investors who:

- plan to hold this investment for the long term; and
- primarily want to gain equity exposure, and can handle the volatility associated with equity investments.

## A word about tax

---

In general, you'll have to pay income tax on your share of the Fund's earnings and on taxable capital gains you realize from redeeming your investment. How much you pay depends on the tax rates that apply to you, and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions of income and taxable capital gains are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

---

The following tables show the fees and expenses you could pay to buy, own and sell Series O Units of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

## Sales charges

---

No sales charges apply when you purchase Series O Units of the Fund.

## Fund expenses

---

You do not pay these expenses directly. They affect you because they reduce the Fund's returns. The Fund's expenses are made up of the management fee, operating expenses and trading costs. The Series' management fee is negotiated on a case-by-case basis with the Manager, but will not exceed the management fee payable on Series A Units of the Fund, which is currently 2.00%. The expenses for this Series are not available because no Units of this Series have been issued.

## More about the trailing commission

Lysander Funds Limited does not pay a trailing commission for this Series of the Fund.

## Other fees

You may have to pay other fees when you buy, hold, sell or switch Units of this Series of the Fund.

Fee	What you pay
Management fee	You pay a management fee to Lysander Funds Limited for services provided to you. The amount of this fee is negotiated on a case-by-case basis with the Manager, but will not exceed the management fee payable on Series A Units of the Fund, which is currently 2.00%.
Short-term trading fees	Up to 2% of the amount redeemed or switched if you redeem or switch within 30 days of purchase. This fee goes to the Fund.
Switch fees	Your representative's firm may charge you up to 2% of the net asset value of the switched Units, as negotiated between you and your representative's firm.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within 2 business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
