- Team based approach to research and investment execution with appropriate valuations paramount.

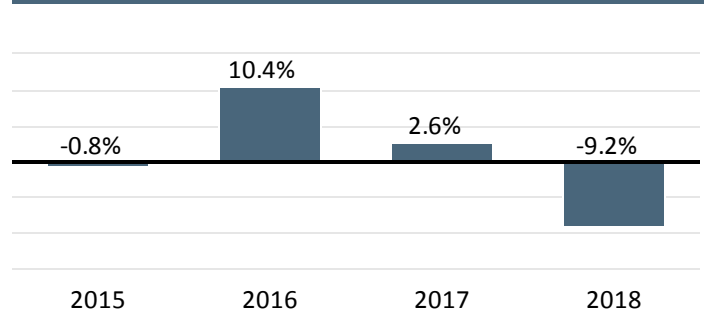

Calendar Year Returns - Series A



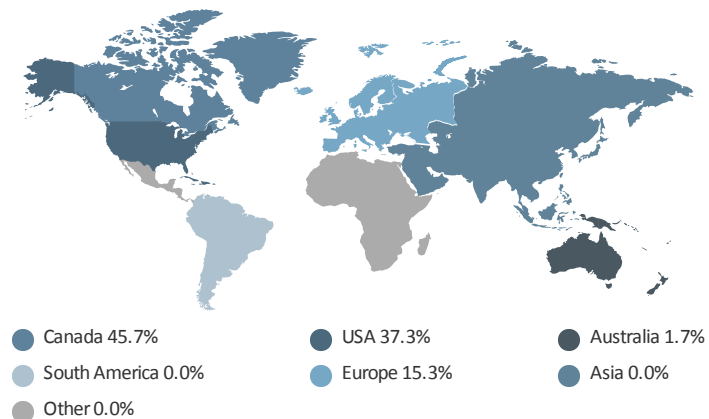
